

## Public Notice

As authorized by Sienco, Inc. ("Sienco") and Viscell Limited ("Viscell"), Wang & Wang LLP hereby makes this statement on behalf of Sienco and Viscell; regarding the exclusive authorized agent of Sienco and Viscell for mainland China.

Sienco, incorporated in the United States, is a technology development and manufacturing company focusing on advanced point-of-care viscoelastic monitoring technology used for coagulation and hemostasis evaluations, and Sienco owns the trademark registrations of SIENCO and SONOCLOT in mainland China. Viscell, incorporated in the United Kingdom, manufactures SONOCLOT products in the UK for Sienco.


Sienco and Viscell authorized Viscell Medical Group (Hong Kong) Limited and its subsidiary, Guangzhou Viscell Medical Technology Co., Ltd. ("VMG") to be the exclusive agent in mainland China since June 13, 2017. VMG is in charge of exhibiting, promoting, negotiating, tendering, distributing the coagulation and platelet function analyzer and all accompanying accessories and disposable supplies under the trademark either SIENCO or SONOCLOT. The current authorization period will expire on January 31, 2028 and it can be renewed as mutually agreed by the parties in the future.

Sienco has been notified that some Chinese companies (listed in the attachment) used the trademarks and products of Sienco without authorization to conduct business activities, such as promotion, and distribution in China. Furthermore, some infringers even forged and used fake authorization documents, and tampered with medical device registration certificates for seeking illegal profits, to seriously infringe the legal rights and interests of Sienco and VMG.

In order to clarify relevant facts and protect the legal interests of buyers and users of Sienco's products, Sienco authorizes this law firm to make the following solemn statements:

1. Use of the trademarks and products of Sienco to conduct promotion, tendering and distribution without authorization, and use and forgery of fake documents, are serious infringements and illegal acts, those who conducted such acts should bear civil and even criminal liabilities in accordance with laws and regulations of the PRC.
2. We hereby notify relevant hospitals that the products of coagulation and platelet function analyzers and all accompanying accessories and disposable supplies marked under the trademark SIENCO or SONOCLOT bought in mainland China, but not distributed by VMG may be counterfeit or shoddy products, and Sienco and VMG are unable to provide any after-sale service.
3. We hereby alert relevant infringers to immediately stop using the trademarks of SIENCO or SONOCLOT on websites, stores or exhibitions and in any promotion or distribution materials, and to stop promoting and distributing counterfeit products under the SIENCO or SONOCLOT trademarks. Sienco will consider all available legal recourse against such infringements
